With the recommendation of the high school principal, a high school junior or senior may enroll in college level credit courses under the **Dual Enrollment Program** (*students receive both high school and college credit upon successful completion of this course*) or the **Advanced Studies Program** (*college credit awarded upon successful completion but no high school credit received*). Students participating in the program must complete all college admission requirements (with the exception of the high school diploma) prior to enrolling.

**Requirements for Dual Enrollment/Advanced Studies:**

1. Must have junior or senior standing in high school and a letter grade average of at least a "B" or a numerical grade average at least 88 (3.0 on four point scale). **Note:** High Schools may require a higher GPA for participation in the program.
2. Students enrolling in English Composition sequence, college level mathematics course, or Western World Civilization sequence, must have appropriate placement levels as determined by the Office of Admissions and Registration Services. (Examples of appropriate placement would be an English or math sub score of 19 or higher on tests such as the ACT or PLAN).
3. Dual Enrollment students must have courses verified for credit by the high school counselor using the form below each semester.

Successful completion of the following postsecondary courses will also satisfy the high school graduation requirements as specified:
